Terms and Conditions for the Buckley's Entertainment Centre "Weber Baby Q This Christmas" Promotion

The promotion, promotional period and promoter

GENERAL

- 18. Any entry in the Promotion which the Promoter determines in its reasonable opinion to be fraudulent will be deemed invalid.
- 19. If the Promoter reasonably suspects that the Winner or redraw winner is not eligible, has breached these Terms and Conditions or has acted improperly to increase their chances of winning, the Promoter reserves the right to refuse to award that Prize.
